Minutes for COUNCIL MEETING of McMaster University Retirees Association,  
**Wednesday September 8, 2010**, 1:30 PM at McMaster Student Centre, Rm 220.

**1. Welcome & Regrets:**

Joe Laposa called the meeting to order at 1:30 PM.

**2. Minutes of Previous Meeting:**

**Moved** by Helen Barton, **seconded** by Beth Csordas that the Council meeting minutes of June 10, 2010 be adopted as corrected. **Motion carried.**

**3. Human Resources Report (Michele Leroux)**

There was no report. During discussion it was agreed that Joe Laposa should seek a meeting between Michelle Leroux and the MURA executive within the next two weeks to discuss items of mutual concern.

**4. Business Arising – updates on**

**4.1 Academic awards and endowment fund raising campaign (Beth Csordas/Helen Barton)**

Beth announced that the current level of the Endowment Fund is \$41,483 which is an increase of \$1,200 from last June's meeting.

Beth raised a number of matters regarding future and past donations as follows.

A meeting has been arranged between Jenny Thompson and Karen McQuigge and the retirees association regarding future fundraising opportunities. Items on the agenda include the next steps with the MURA scholarship and prize fund and plans for next year's campus community campaign which encourages giving back to McMaster from the various campus constituents, faculty, staff and students, and also includes the university event series, 'Doors Open McMaster'. Another item to be discussed at the meeting would be the possibility of including retirees in the various projects and events.

Helen has queried by email if it's possible to have the MURA Fund added as a Gift Designation choice on the online donation page. The MURAnews committee has been talking about how to promote donations and think that they would really like to feature the online option and making a gift "in honour or memory", but feel it would be much more appealing to people if they could "pick" MURA from the list rather than having to write it in as a Special Instruction. In response, Jenny Thompson had a "fund specific" web page created for the MURA fund.

Finally Beth noted that we have fallen behind (Sep 09 to Aug 10) in our thank you notes to MURA donors, but we need an updated donor list before we can act on this.

#### **4.2 Revised portfolio descriptions (Wayne Rouse)**

The updating of the portfolio descriptions is coming along well. There are still a few updates that need to be dealt with. It was agreed to by Council that the revised portfolio descriptions should be posted on the web with notification to Council that they should be checked for accuracy and/or need of further revision.

#### **4.3 Bookstore discounts (Joe Laposa)**

Joe wrote to Donna Shapiro on possible discounts for MURA members. Donna turned the query over to Stacey Gabitous. Stacey indicated that there are no special deals for MURA members or for anyone else in the McMaster Community. However, she did indicate that events could be organized possibly accompanied by special perks. Discussion took place about possibilities of organizing a special event at the bookstore following the Christmas luncheon. Joe Laposa said he would pursue this possibility with Stacey.

#### **4.4 Abolishing tuition for students over 65 (Joe Laposa)**

This is currently a non-issue having being put on hold by the University

Administration.

#### **4.5. MURA Treasurer (Joe Laposa)**

Joe gave a brief history on the recent situation regarding MURA treasurer. Beth Csordas currently is treasurer and vice-president. She does not wish to be president in the future. She will remain as vice-president to the end of the 2010-2011 year after which she would step down from the vice-presidency but continue to act as treasurer. Council endorsed this scenario. Kathy Overholt moved that we express our delight with Beth's decision to continue in both portfolio roles. Seconded by Stefania Miller. Carried.

#### **4.6 Committee changes, portfolio reassignments (Joe Laposa)**

It was noted that Kathy Overholt will be acting as liaison with CAW.

MURA needs a Special Events chair or co-chairs. The possibility of Shari Mercer and Mary Johnson taking part in this portfolio was raised, and Joe Laposa will explore this with Shari and Mary this upcoming Monday, when they return from Cape Cod. A number of names were mentioned of people who might contribute to Special Events.

#### **4.7 Parking (Helen Barton)**

There have been a number of problems with retiree parking that have arisen this summer. Helen will set up a meeting between herself, Joe and Beth and Terry Sullivan in his office. In addition to resolving current problems the idea of instituting permanent retiree parking permits will be raised at this meeting.

The installation of this system is almost complete and the procedures to follow will be outlined shortly on the MURA retiree's website and will be additionally noted in MURAnews.
